Purpose of This Phase

- Identify **priority crops** to push immediately
- Rank crops by **income potential, ease of adoption, and demand**
- Guide Country Directors on **where to focus training, inputs, and logistics**
- Prevent dilution of effort across too many low-impact crops

A. TIER 1 CROPS – CORE STRATEGIC CROPS (GLOBAL PRIORITY)

Multi-product, high demand, scalable across regions

These should form the **backbone of WEMPOWER GLOBAL contracts**.

Aloe vera	Hardy, fast uptake, year-round harvest	Skin, hair, supplements
Moringa	Fast rotation, nutrition + pharma	Supplements, food
Ginger	High global demand	Supplements, massage
Turmeric	Strong medicinal branding	Supplements, skin
Coconut	Multiple derivatives	Food, skin, hair
Avocado	High-value oil	Skin, hair, nutrition
Sesame	Drought tolerant, oil-rich	Massage, cosmetics
Castor	Hair growth demand	Hair, skin

B. TIER 2 CROPS – HIGH-MARGIN SPECIALTY CROPS

Lower volume, higher value, quality-sensitive

Lavender	Temperate zones	Essential oils
Chamomile	Temperate	Skin & calming
Frankincense	Arid Africa	Premium resins
Myrrh	Arid zones	Therapeutic balms
Sea buckthorn	Cold/temperate	High antioxidant
Goji berries	High altitude	Export nutraceuticals
Ginseng	Cool climates	Adaptogens

Directive:

Promote via **trained clusters and cooperatives**, not mass rollout.

C. TIER 3 CROPS – FAST CASH-FLOW & ENTRY CROPS

Low capital, short cycles, ideal for onboarding members

Crop	Cycle	Ideal For
Lemongrass	4–6 months	Oil extraction
Basil / Tulsi	2–3 months	Beginners

Deploy in **urban, peri-urban, youth, and tech-enabled groups**.

Africa (Tropical / Arid / Highlands)

- Core: Aloe, Moringa, Ginger, Turmeric, Sesame, Neem
- Specialty: Frankincense, Myrrh, Hibiscus
- Controlled: Spirulina, Mushrooms

Asia

- Core: Turmeric, Ginger, Neem, Coconut, Sesame
